Corporate Political Activity Policy

Cardinal Health, Inc. believes that as a responsible corporate citizen, it is important to participate in the political process by using our unique knowledge and experience in healthcare to help inform and advise policy makers on matters that impact the quality, effectiveness, and affordability of healthcare and impact our company, customers, shareholders, and employees. Consistent with our *Standards of Business Conduct*, our policy reflects our commitment to comply with federal, state, and local laws and regulations governing political contributions and lobbying.

The vast majority of our political contributions to state candidates, and all of our contributions to federal candidates, are made by the Cardinal Health Companies Political Action Committee (“PAC”), and not with corporate funds. Formed in 1999, the PAC supports the campaigns of those candidates who understand the issues critical to Cardinal Health and our industry. While the PAC is administratively supported by Cardinal Health, it is funded entirely by voluntary contributions from our employees.

Approval Process and Board Oversight

The Nominating and Governance Committee of our Board of Directors is responsible for the oversight of our policies and practices regarding political expenditures, including an annual review of our political contributions policy and corporate political contributions and trade association dues and payments. We have adopted a corporate political contributions policy setting forth the process and standards governing our corporate political contributions.

Under this policy:

- We may not contribute corporate funds to political parties, judicial campaigns, presidential campaigns, SuperPACs, or federal candidates.
- We may not fund independent communications (those not made through a particular campaign or candidate) in connection with any federal or state candidate’s election, and thus may not make expenditures of the type permitted in the *Citizens United* case.
- In limited circumstances, we may contribute corporate funds to state political candidates if permitted under state law and if contributions by the PAC are impractical. We also may use corporate funds to support ballot or bond initiatives at the state or local level. These expenditures are limited in practice, must be approved in advance by our Chief Legal and Compliance Officer and our Senior Vice President, Government Relations, and are subject to oversight and annual review by the Nominating and Governance Committee.

We apply our political contribution policy to fees that we pay to trade associations in the United States and direct major trade associations (i.e., those whose membership dues exceed \$50,000

annually) not to use our funds for political campaign expenditures, unless approved by our Chief Legal and Compliance Officer and our Senior Vice President, Government Relations. To date, no exceptions have been approved.

Under our policy, political contributions and expenditures must reflect Cardinal Health's interests or those of our industry, and not those of individual officers or directors. Our decision to contribute to a candidate or organization does not mean that we agree with every position taken by them. We make political contributions to candidates from both parties, considering such factors as constituent presence, the candidate's leadership position or committee membership, and the candidate's understanding of the issues that are important to our business and industry.

PAC Contributions

In 2018, PAC contributions to federal and state candidates totaled \$462,050 in the aggregate. We are required by federal law to file regular reports disclosing all political contributions made by the PAC. Corporate Political Contributions

In 2018, we did not make any contributions from corporate funds to state candidates or to state or local ballot initiatives.

Lobbying Activity

Lobbying is highly regulated in the United States, and we comply with U.S. federal and state laws, including the Lobbying Disclosure Act and Honest Leadership and Open Government Act, which require reporting on lobbying activities and certification of compliance with Congressional gift rules.
